

Model Release And Independent Contractor's Agreement

Excite Boys Inc.

This Model Release and Independent Contractor Agreement (hereinafter "Agreement") is made this day, _____, 2008, by and between Excite Boys Inc. (hereinafter "the Company") and _____ (hereinafter "Model").

In consideration of the mutual promises contained herein, the Company and Model agree as follows:

1. Performance of Services:

Model offers, desires and agrees to perform services for Company as a self-employed independent contractor. The services, activities and skills (hereinafter "Services") to be provided by Model include: Professional modeling services and services incidental thereto, including but not limited to modeling for the purpose of creating images such as pictures, portraits, photographs, films, and videotapes, for use in all forms and in all manner of media, including composite or distorted representation, for the purposes of advertising, trade, publication, promotion, exhibit, sale, licensing, or any related purposes in the sole discretion of the Company. Model shall use his/her best efforts to perform the Services in a manner satisfactory to the Company.

Model hereby expressly acknowledges and agrees that the Company, its affiliates, subsidiaries, officers, directors, employees, agents, representatives, successors, assigns and licensees shall have Model's unconditional authorization, consent, and approval to take explicit photographs, films and/or videos of Model while Model is performing said Services in the nude, partially nude, and/or clothed.

2. Warranty of Age:

Model hereby warrants and declares under penalty of perjury that he/she is at least eighteen (21) years of age as of the date of the execution of this Agreement. Model further warrants that he/she is able and competent to enter into contracts on his/her own behalf. Model agrees to provide the Company with his/her true, correct, and accurate driver's license, state ID and/or original birth certificate, for photocopying by the Company and to be attached as Exhibit A hereto and incorporated by reference herein.

3. Ownership of Images:

Model expressly agrees that the Company shall have the exclusive right to copyright, use, reuse, publish, republish, distribute, disseminate, sale, license, and otherwise use in any manner at the Company's sole discretion any image and voice recording created pursuant to the Services provided by Model to the Company under this Agreement. This use, reuse, publication, republication, distribution, distribution, license, and/or sale of the subject matter may be performed in conjunction with any media, presently known or unknown, including but not limited to the internet, magazines, books, videos, CD-Roms, DVDs, and other electronic media. Model expressly agrees that he/she shall have no ownership interest at any time in any images created pursuant to Model's performance of Services under this Agreement. The Company shall exclusively own any such images and the copyrights for the images in perpetuity from the time of the performance of the Services. This right of ownership does and will survive the termination of this Agreement. Model waives the right to inspect or approve any image created pursuant to this Agreement. Model expressly waives any right or claim to the images or to any works derived therefrom.

The Company may use in any manner at its sole discretion all images created pursuant to this Agreement in which Model may be included, and any information pertaining to Model, whether true or fictional, with or without Model's name, for any purpose whatsoever, in any form or publication.

4. Payment:

For performance of the Services, Model shall be entitled to monetary compensation as specifically set forth in Exhibit B attached hereto and made a part hereof for all purposes.

5. Independent Contractor:

Model's relationship with the Company shall be that of an independent contractor and not that of an employee. Model may cease to perform the Services at any time. As an independent contractor, Model will not be eligible for any employee benefits, nor will the Company make deductions from Model's compensation. Model will be responsible for the payment of all income, social security, and other taxes due on all payments made to Model under this Agreement. Model agrees to indemnify and hold the Company harmless from any liability for, or assessment of, such taxes. Model shall have no authority to enter into contracts that bind the Company or create obligations on the part of the Company.

6. Model represents that he/she is in good health and has no known sexually transmittable diseases. Model further acknowledges that sexual contact with others carries inherently dangerous risks and Model agrees to assume the risk associated with such activities. For consideration paid herewith, Model waives, releases and discharges Company from any and all liability arising from the sexual activities taken pursuant to this Agreement.

7. Indemnification:

Model expressly agrees to indemnify and hold harmless the Company from any and all actions, claims, damages, demands and liabilities of any kind whatsoever arising out of, concerning or related to any falsehoods or misrepresentations made by Model in accordance with his/her performance of the Services hereunder, including but not limited to a misrepresentation of Model's age or a misrepresentation of Model's competency to enter into this Agreement.
